- DUTIES: Under the supervision of the Water Pollution Control Authority Bureau Chief or designee is responsible for ensuring City agency, resident and business compliance with environmental permits, procedures and mandated regulations pertaining to waste and storm water; performs other duties as assigned.
- MINIMUM QUALIFICATION REQUIREMENTS: Graduated from an accredited college or university with a bachelor's degree in a natural, physical or biological science or an enforcement discipline and four (4) year experience in law or regulatory enforcement or compliance, at least two (2) of which shall have been in a government setting or an equivalent combination of education and experience.
- SPECIAL REQUIREMENTS:
 - At time of application, must possess a valid motor vehicle operator's license.
- PHYSICAL REQUIREMENTS/WORKING CONDITIONS:
 - Physical ability to sit for extended periods; mobility to bend, stoop, reach, climb, stand and walk on uneven or slippery terrain; strength to safely lift and carry objects 40-45 pounds. Work will include working indoors, outdoors, day or night, evenings or weekends and in adverse physical and climatic conditions. Work may include exposure to dust, chemicals, insects, physical hazards and difficult and/or hostile individuals and situations.
- SCOPE OF EXAMINATION: Qualified applicants will be evaluated, scored and ranked on level and quality of related experience, education and training as documented on the application and supplement. Incomplete applications will not be considered qualified.
- *FILING REQUIREMENTS: A completed "City of Stamford Application for Examination or Employment" and "Application Supplement '09-23" must be submitted or postmarked on or before the last filing date to be considered eligible for purposes of this examination. A resume and/or other correspondence will not be considered as equivalent to an application.
